## **DELIVERY / RETURN POLICY**

Participants (individuals and / or legal entities) have the right to waive the participation fee, without penalties and without invoking a reason, within 30 calendar days from the time of purchase.

To make a return on the website <a href="www.iscp2022.ro">www.iscp2022.ro</a>, the participant must send a written request to <a href="mailto:office@mediamed.ro">office@mediamed.ro</a> or call +40 31 101 32 21. In the request the participant will mention the name and surname, the name of the event for which he paid the participation fee, the date of acquisition and the amount paid.

## **Participation fee**

The participation fee includes value added tax (VAT).

The participation fee differs for each participant depending on the professional category to which he belongs and the <a href="mailto:membership">membership</a> status acquired in the ISCP – International Society of Cardiovascular Pharmacotherapy.

The participation fee is paid through the online payment platform.

ISCP reserves the right to limit participants to a single purchase of the participation fee per email address.

## Participation fee delivery / Conference access

If the participant does not fill in the registration form, he / she can be considered as not being registered and cannot subsequently receive the access / login data.

## Participation fee return

Participants (individuals and / or legal entities) have the right to waive the participation fee, without penalties and without invoking a reason, within 30 calendar days from the time of purchase, regardless of the payment method chosen.

The request for return will be made in writing to the email address office@mediamed.ro or call +40 31 101 32 21. In the request the participant will mention the name and surname, the name of the event for which he paid the participation fee, the date of purchase and the amount paid.

In case of return of participation fees, Media Med Publicis will reimburse the value of the fees by the same method by which they were purchased unless the participant has agreed to another payment method.

Media Med Publicis reimburses all amounts received as payment from the participant, within 30 calendar days of receiving a written request for a return from the participant.
